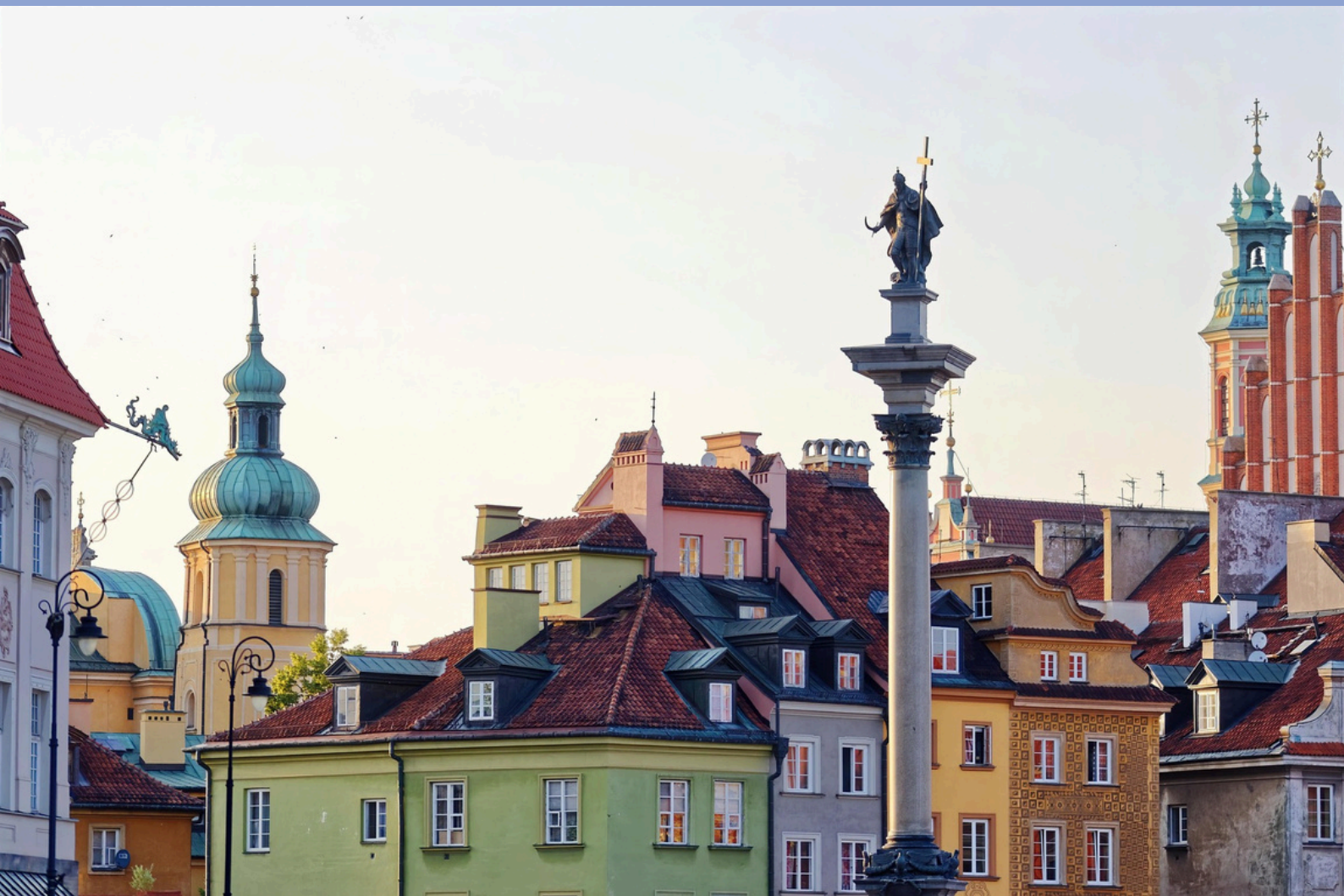


# CONFERENCE ON SAFEGUARDING AGAINST SEXUAL VIOLENCE IN CHURCHES

WARSAW, 19-21 JUNE 2026

Many churches in Europe are currently grappling with the issue of sexual violence: in terms of addressing and acknowledging it, as well as preventing it and intervening in suspected cases. At its 9th General Assembly in Sibiu in 2024, the CPCE called on its member churches to raise awareness of sexual violence and to take action to combat it. At this conference, representatives of Protestant churches in Europe will share their experiences of safeguarding measures, assess their suitability for different contexts, and establish networks to support each other in implementing proven concepts. The focus is therefore explicitly on prevention and intervention. Churches with little experience in this area are particularly encouraged to attend. The conference marks the start of a multi-year implementation process. The conference is being held in cooperation with the Guido Fluri Foundation in Switzerland.

The Guido Fluri Foundation's popular initiative led to a comprehensive reappraisal of past cases of abuse in Switzerland. The redress also covered abuse in a church context. The foundation subsequently launched the European Justice Initiative with the aim of comprehensively improving child protection. In 2024, the Parliamentary Assembly of the Council of Europe voted in favour of a resolution by the European Justice Initiative. Resolution 2533 requires member states to review cases of abuse in their own countries based on the Swiss model.
